Re: Sub-division of shares

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the information pertaining to sub-division of shares is as follows:

- a) Split Ratio: 10 Equity Shares for every 1 Equity Share held
- b) Rationale behind the split: In order to improve liquidity of the Company's share and with a view to encourage the participation of small investors on the stock market, the Board of Directors at its meeting held on 28th June 2016 considered and approved the sub-division of equity shares of the Company having a face value of Rs. 10 per share into equity shares having a face value of Re. 1 each, subject to the approval of the shareholders of the Company and statutory approvals. This would make the equity shares of the Company more affordable.
